Many Federal and State laws require public schools to provide parents with information and notices as it pertains to their children's school, academic progress, teachers, and much more. In an effort to present all of this information in the most accessible and understandable format for parents, the district has chosen to publish an annual "Parent Notice of Rights and Policies" via the district website at <http://www.triadunit2.org>. The contents of this section contain additional information and links to assist parents in understanding their child's rights and are summarized in the following areas:

- 1. Notice of Nondiscrimination** - School District does not knowingly discriminate against any person on the basis of race, creed/religion, color, national or ethnic origin, sex, disability, marital status or age, in admission or access to, treatment or employment in, or participation in its programs and activities, pursuant to federal and state law.
- 2. Notification of the Student Harassment Policy**- No person, including a District employee or agent, or student, shall harass or intimidate another student based upon a student's sex, color, race, religion, creed, ancestry, national origin, physical or mental disability, sexual orientation, or other protected group status.
- 3. Notification of Uniform Grievance Procedure**- This notice is provided to inform students and their parents of the procedures to be followed at the local level when addressing complaints alleging unlawful discrimination or failures to comply with state and federal law.
- 4. No Child Left Behind Notification** – Legislation enacted to ensure that all children have a fair, equal, and significant opportunity to obtain a high quality education and reach, at a minimum, proficiency on challenging state wide academic achievement standards and state wide academic assessments. As a result of NCLB, parents have a right to request information about the educational qualifications of their children's teachers.
- 5. IHSA Eligibility** – The IHSA governs the equitable participation and regulates interscholastic competition in 13 boys and girls sports, as well as 7 non-athletic activities that enrich the educational experience. As a member, our District has elected to abide by the associations Constitution, By-laws and Policies which are outlined each year.
- 6. State Pupil Transportation Reimbursement Notification** - Notifies parents of students not eligible for free transportation to and from school of the conditions required for which they may be eligible for reimbursement of the cost of transporting their child.
- 7. Parents of Students with Disabilities: Notice of Procedural Safeguards** - a document that is designed to assist the parent in understanding the special education process and the rights of the parents when their child has been referred for or is receiving special education services.
- 8. Illinois Textbook Loan** – This program has allocated funds on a yearly basis to our school district to assist in defraying costs associated with the purchase of textbooks and instructional materials. The notification explains that the instructional materials purchased through this program belong to the state and may continue to be loaned on the behalf of parents by the school district.
- 9. Family Educational Rights and Privacy Act (FERPA)** Provides an eligible student or parents certain rights over the student's education records. These rights include the right to inspect and review student records, the right to request amendment of records that the parent or eligible student believes to be inaccurate or misleading, the right to consent to disclosure of personally identifiable information contained in student records, and the right to file a complaint with the Dept. of Education.
- 10. Structural Pest Control Notification** - School districts must maintain a registry of parents and guardians of students and employees who have registered to receive written or telephonic notification prior to application of pesticides to school property.
- 11. Annual Asbestos Notification** - Parents are advised that steps are continually being taken to manage and/or remove the asbestos in our school buildings. Every six months a periodic inspection will occur throughout the building. This inspection will insure that every six months that all asbestos has been checked for any changes in condition and management plans are available for review.
